

ADSA Board Meeting  
February 10, 2015  
Minutes

- 1) Opening Prayer- meeting called to order at 2:04 pm, prayer offered by Jon Clemens  
Introductions of everyone for visitors and the new members of the board (Matt from Regis). Guest at the meeting is Andrew Woodward from Trinity.
  
- 2) College Reps
  - St Mikes: an agreement with the union was reached so no strike, Search in process for a new Dean, had an epiphany party in Jan., today (Feb 10) Mass in the Coptic tradition will be offered in St Basil's, March 20- Theology and Ecology lecture, Trip to Montreal is planned to explore the Silent Revolution
  - TRIN: Jonathan successfully defended his thesis proposal, No further report.

  - the complaint centered around ATS nomenclature: was supposed to be a change in only minor ways, but TST (and the university) see it as a completely new program.
  - ATS it seems is confused about what is happening here
  - ThD is seen as a professional degree, and the PhD is seen as a research degree
  - Creates issues with students transferring to get the new degree

The board objects to the ATS complaint but agrees with the subject matter of the complaint and that there are issues with the program. We desire for a widening of the bridge program

Becca suggests meeting with Jerry, Bradley, and David Neelands, about this issue asking what the rationale is for certain numbers and the cutoff for switching.
