- Everyone believes the issues raised here are very serious; TGSA needs to work hard to advocate for students in the wake of these changes
- Marie was commissioned to liaise with UTSU re: an "opt-in" procedure for non-conjoint students
- TGSA will request that library access be standardized across all colleges and that TST do everything under its power to resolve the OSAP status issues
- Communication to go out to students regarding OSAP deferment procedures and letting them know what the Board is working towards on their behalf
