 - There will be a panel discussion on the Saturday, May 9th with a third keynote speaker; TST is hoping for a moderator (the Saturday is more open to the public); students are welcome to put in proposals for this part of the conference which will be held at Carr Hall.
 - If TGSA joins with TST it will give more momentum to our conference; should someone from TGSA be on the TST planning committee?
 - How should we relate our conference topic to TSTs? Broad, wider scope? Maybe reflecting on meaning and theological significance of the university campus? Do we want something more distinctly theological? Regardless, we should still link the themes NB: We need to finalize this at our next meeting.
 - We should have our own separate Call for Papers one to TST and then one to TGSA.

- It'll bring more faculty advantage for CV being associated with the wider TST rather than just TGSA but it will be a distinctly TGSA conference.
- Mike A. mentions language, maybe use "pre-conference" language rather than just conference so there isn't any confusion between the TGSA and TST conference.
- Sam N. offers "value of dialogue" or "value of ecumenism" as titles.
- Fiona L. asks what date do we want to send out Call for Papers? Mike R. says we should send out Call for Papers in the next couple of weeks (so around the time of our next general meeting)
