- Treasurer's Report:

 - Leanne asks: How much do we want to offer for the conference grant (winter)? The grant is offered through TST.
 - We haven't spent as much as we intended for our monthly events, hence why there is available finds which can be used to up the conference grant
 - M.J. P.: What about gift cards (for area rep events)? Leanne K.: We would need to write a proposal for something like that and there would also need to be a set of guidelines attached; it has to be put in the budget at the beginning of the year; it may be beneficial to think about having an allotted sum of money that can be used for gift cards in the 2020/21 academic year.

P says there needs to be an extension given to those students because not all Deans do so.
