    - Most of the meeting consisted of Pam Couture walking those present through a series of coloured charts (in draft format), that clearly designate who (students, faculty supervisors, administrators, and staff) is responsible for various items in the DMin program, and how and when those items are to be addressed. [These charts are to be made available and when they are, I will send them to you.] The response to these charts was quite positive. [I surmise that something similar will be put into place for the PhD.]
    - The admin realizes that clearer and specific direction is need for the DMin Comprehensive Exam and will work on this.
